#### What is going on now?

- The US Supreme Court put a freeze on New York's eviction moratorium. But do not move out! Tenants have other protections!!
  - o Homeowners can still file a Hardship Declaration to stall their foreclosure.
- Tenants are protected from eviction if they file for ERAP (EMERGENCY RENT ASSISTANCE PROGRAM)
- The NYC Right to Counsel law protects all tenants with cases in Housing Court.
- The Tenant Safe Harbor Act protects tenants from eviction in nonpayment cases also.

# Existing Protections For Tenants

THE LEGAL AID SOCIETY **ERAP** – Tenants who apply for ERAP are protected from eviction while their application is pending

**Tenant Safe Harbor Act** – Tenants impacted by COVID-19 have an affirmative defense to eviction for nonpayment of rent

#### **CDC Eviction Protection Declaration**

 May offer limited protection for tenants not eligible for ERAP \*The
 Supreme Court struck down the
 CDC Moratorium

#### Your Rights As A Tenant

- If you applied for ERAP, the Court should pause your eviction case
- You have a right to stay in your home until a judge orders you to leave.
   Its illegal for a landlord to change the locks on you.
- If you need repairs, or you are being harassed by your landlord, you can start a case in Housing Court

#### **OCJ's Legal Services for NYC Tenants**

- HRA's Office of Civil Justice (OCJ) provides free legal services to New York City tenants facing eviction, harassment, disrepair and other housing-related issues.
- OCJ is implementing New York City's right-to-counsel (RTC) law ensuring that all tenants facing eviction cases in court have access to free legal assistance.
- In addition to RTC, OCJ provides access to free legal assistance for tenants in a range of housing-related cases. OCJ supports legal representation and advice programs for New York City tenants to help maintain and preserve their housing and protect against harassment, disrepair or other misconduct by unscrupulous landlords.
- OCJ has also established a Housing Help Hotline accessible via the City's Tenant Helpline/311 to provide phone-based advice and information to NYC tenants with questions or concerns about landlord-tenant issues.
- OCJ's legal services are available citywide in every ZIP code and regardless of immigration status.



#### **NYC's Right-to-Counsel Law**

- NYC's RTC program is administered by OCJ and legal services are provided by contracted nonprofit legal services organizations from across the five boroughs.
- City-funded legal services are available for all tenants facing eviction in housing court or NYCHA administrative proceedings - at or close to the first court appearance.
- **Legal representation** for tenants with households at or above 200% of federal poverty guidelines (approximately \$53,000 for a family of four), and **brief legal assistance** for those earning more.
- RTC legal providers are available to assist unrepresented tenants in eviction court conferences (appear by teleconference or in-person)



#### KCS Mission Statement

## What is the Emergency Rental Assistance Program (ERAP)?

- Assist households behind on their rent that have experienced financial hardship due to COVID-19 and can provide:
  - Rental Arrears (up to 12 months)
  - Prospective rent (up to 3 months)
  - Utility arrears (up to 12 months)



#### Do I Qualify for ERAP?

- Eligible residents must meet ALL the following criteria:
  - Household Gross Income at or below 80% of area median income (AMI).
  - Member of household received unemployment insurance, or experienced financial hardship due to COVID-19.
  - Applicant owes past due rent at their current residence.


#### How Do I Apply for ERAP?

- Tenants and Landlords must apply on the OTDA Portal:

#### **Emergency Rental Assistance Program**

The Emergency Rental Assistance Program (ERAP) will provide significant economic relief to assist households that are unable to pay rent and utilities due to the COVID-19 pandemic. The funds are provided directly to States, U.S. Territories, local governments, and Indian tribes. Grantees use the funds to provide assistance to eligible households through existing or newly created rental assistance programs.

#### WHAT IS THE EXCLUDED WORKERS FUND?

A one-time payment to workers who lost income between March 27, 2020 and April 1, 2021 but are excluded from state Unemployment Insurance (UI) and federal COVID-related assistance.

• Tier 1 amount of \$15,600 (minus taxes), applicants need to establish a minimum of 5 points of documents.

• Tier 2 amount of \$3,200 (minus taxes), applicants need to establish a minimum of 3 points of documents.

#### WHO IS ELIGIBLE?

- 1. Lived in New York State before **March 27, 2020**, and continue to live in New York State;
- 2. Are not eligible for and did not receive unemployment insurance or any other COVID-19 income relief or other specified benefits from the state or federal government;
- 3. **Earned less than \$26,208** in the 12 months prior to April 2021; and
- 4. Lost at least 50% of weekly work-related earnings or household income at any point in time between February 23, 2020 and April 1, 2021 due to total or partial unemployment, or inability or unavailability to work due to the COVID-19 pandemic or, became responsible for a majority of their household income due to death or disability of the head of household

#### WHAT DO YOU NEED AND HOW TO APPLY:

- Applicants need to have documents that prove
  - o identity, residency, and work-related eligibility
